RECOMMENDATION.

Accept the work performed for the North San Fernando Road Park (PRJ20915) Phase Two Project (Project) that was designed by the Department of Recreation and Parks (RAP) Planning, Construction and Maintenance (PCM) staff and constructed by RAP's as-needed prequalified on-call contractors, as outlined in this Report.

SUMMARY

North San Fernando Road Park is located near the corner of North San Fernando Road and Astoria Street in the Sylmar community of the City. This 0.24-acre site was donated to the City of Los Angeles (City) by the developer of an adjacent 84-unit residential development project (Report No. 16-232). Approximately 1,986 City residents live within a one-half (1/2) mile walking distance of North San Fernando Road Park. Due to the facilities, features, and services it will provide once complete, North San Fernando Road Park will meet the standard for a Neighborhood Park, as defined in the City's Public Recreation Plan.

As a part of the donation of the park site to the City, the developer was required to complete Phase One of the development of North San Fernando Road Park (Report No. 16-232). The scope of Phase One included grading, landscaping, utility installation, and fencing. Phase Two of the park development was to be designed and constructed by RAP. Phase Two's scope of work was approved by the Board of Recreation and Park Commissioners (Board) on January 3, 2018 (Report No. 18-002).

PROJECT SCOPE

The design and construction of Phase Two of the park development is now complete. The scope of work for the Project included new play equipment/surfacing, new fitness equipment/surfacing, irrigation, landscaping, security lighting, and park site amenities such as trash cans, benches, and drinking fountains. ADA access was provided to all site features and the planting and irrigation conformed to RAP's standard regarding sustainability and maintenance.

The total Project cost is Two Hundred Forty-Eight Thousand, Nine Hundred Eight dollars and Forty Nine Cents (\$248,908.49). This amount includes the following:

Expended to Date: \$194,947.83, Encumbered to Date \$47,593.87, RAP Labor invoice but not yet reimbursed: \$6366.79, which add up to \$248,908.49.

PROJECT FUNDING

\$320,130.00 in Quimby Fees was transferred from the North San Fernando Road Park Account No. 89460K-XX and was allocated to the Project pursuant to Board Report No. 18-002.

The total Quimby Fees allocation for the North San Fernando Road Park – New Park Development Phase Two (PRJ20915) Project was \$320,130.00.

These Quimby Fees were collected within two (2) miles of North San Fernando Road Park, which is the standard distance for the allocation of the Quimby Fees for neighborhood recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3.

PROJECT CONSTRUCTION

The project was bid out through the RAP On Call list for new park facility construction. The winning bidder was Evergreen Construction with a bid of \$156,250. The Notice to Proceed (NTP) was issued 1/17/2018. The shade structure portion of the project was awarded to our on call vendor for the manufacturing and installation of shade structures for a cost of \$56,210. The NTP was issued 07/11/2018. One change order for the shade structure was issued on 03/12/2019 for the amount of \$823.87 for additional permit fees. The Project was completed to on July 31, 2019 and the contractor has furnished the department with all required permits, warranties guarantee's and operation and maintenance manuals. There has been no contract compliance or labor issues with the work done at the park.

TREES AND SHADE

As part of the Project, ten (10) box trees were installed. They are: three 24"box Arbutus unedo, three 36" box Lirodendron tulipifera, and four 24" box Lagerstroemia indica. Additionally, a free standing shade structure has been installed as a part of the Project. At full maturity Lagerstroemias and Arbutus will get over 25' in height and 25' in spread and the Lirodendron will get over 40' in height and 25' spread and will provide a shade canopy for 60% of the park.

ENVIRONMENTAL IMPACT

The Project has been previously evaluated for potential environmental effects and was determined to be exempt from the provisions of the California Environmental Quality Act (CEQA). A Notice of Exemption was filed with the Los Angeles County Clerk on June 20, 2013. The acceptance of this completed Project will not result in any additional environmental impacts, therefore no additional CEQA documentation is required.

FISCAL IMPACT

Funding for the maintenance cost of the Project will be requested through RAP expanded facilities budget request process.

STRATEGIC PLAN INITIATIVES AND GOALS

Approval of this Board Report advances RAP's Strategic Plan by supporting:

1. GOAL: To Create and Maintain World Class Parks and Facilities

2. OUTCOME: Provide a site specific design solution that creates an Iconic imagery for

the park and through the use of sustainable landscape practices,

irrigation and materials reduce the park green waste.

RECOMMENDATIONS

- Adopt the proposed Resolution, herein included as Attachment 1, authorizing the acceptance of the donation of six (6) vacant property parcels in fee title via Grant Deed, contingent on the clearance of all environmental conditions, review of title and approval for acquisition by the Department of General Services (GSD), for the conveyance of approximately 10,278 square feet or .24 acres, located near the corner of North San Fernando Road, and Astoria Street;
- Authorize the Board Secretary to execute the escrow instructions and Grant Deed for the subject property, as approved by GSD and by the City Attorney's Office;
- Authorize and request GSD to acquire and process the conveyance of the donation for parcels LOTS 52 THROUGH 57 INCLUSIVE OF PROPOSED TRACT MAP NO. 68157 to the Department of Recreation and Parks (RAP) as identified in proposed TRACT MAP NO. 68157; and as described in conditions of approval for Tentative TRACT MAP 68157;
- 4 Condition the conveyance and acceptance of approximately 10,278 square feett or .24 acres of vacant property located at the approximate location of 12385 North San Fernando Road near the corner of North San Fernando Road, and Astoria Street contingent upon the following prior conditions and actions taking place:

- D. Subdivider shall provide six (6) improved open space lots graded, landscaped with utility connections/abutments and gated and fenced to the satisfaction of RAP Planning, Construction and Maintenance staff.
- Approve the final Phase I Design Plan (approved by staff) for the North San Fernando Road Park, as described in the Summary of this Report and shown on Attachment A (For Reference Only).

SUMMARY

As part of the Tract Map Development Project (Project), RAP proposes to accept the donation of six lots and develop approximately 10,278 square feet or .24 acres of the 6 (six) vacant lots located at 12385 North San Fernando Road near the corner of North San Fernando Road, and Astoria Street in the Community Plan Area of Sylmar in the City of Los Angeles. The Project site was identified by the Office of Council District Seven of the City of Los Angeles as an opportunity develop and provide open space/park amenities as part of a Tract Development that will serve the proposed development of new homes and surrounding areas. An estimated 1,986 residents live within a one-half mile walking distance of the proposed new park.

The park project portion of the Development of Tract Map No. 68157, is proposed to be developed in two phases. Phase I development of the park portion will be undertaken by the subdivider as approved by RAP staff. The larger Tract map development will consist of a development of 90 lot subdivision consisting of 84 single family detached homes. The housing development is located adjacent to Berg Street, El Dorado Avenue to west and San Fernando Road to the north. It is envisioned that the housing development and surrounding community will have the use of a RAP developed park centered in the north east portion of the development, facing North San Fernando Road made up of six donated vacant lots that eventually will be developed into a park by the RAP. The donated lots that will become the Park Project is proposed to be developed in two phases on the portion of the development tract site that is currently vacant but will be graded, landscaped, with utility connections/abutments and gated and fenced to the satisfaction of RAP Planning, Construction and Maintenance staff by the Tract Map sub-divider as part of the conditions of approval for the TRACT MAP NO. 68157. A map and rendering of the Project site as visual aid and for reference only is shown as Attachment A2.

In order to enable RAP to accept and develop the vacant lots for use as a park as part of the park development project, the property owner or subdivider will secure all permits needed as part of its conditions of approval in order to provide the components of the Phase I obligations. All costs

related to the Phase I improvements or landscape improvements will be incurred by property owner and it is anticipated that it will take several months to complete. Once the Landscape improvements are complete, and the tentative tract map has been approved, the property owner has agreed to transfer the vacant lots (LOTS 52 THROUGH 57 INCLUSIVE OF PROPOSED TRACT NO. 68157) to RAP for no consideration.

Final Landscape Design

The Project will be constructed in two Phases. Phase I construction will be provided by Subdivider and Phase II construction will be provided by RAP.

Phase I - Subdivider

Subdivider shall provide six (6) improved open space lots graded, landscaped, with utility connections/abutments and gated and fenced to the satisfaction of RAP Planning, Construction and Maintenance staff.

Phase II - RAP

The final completed park design or conceptual design and its construction will be the responsibility of RAP. The public park will include playground areas with resilient surfacing, a walking path, fencing and landscaping, and typical park amenities including benches, trash receptacles, and lighting trees and shaded areas.

FUNDS

Quimby funds will be used to develop park along with undetermined RAP funds.

NEEDS ASSESSMENT

The proposed property donation to RAP to be known as the North San Fernando Road Park property will provide a neighborhood park/open space in an area where City residents do not have sufficient access to improved open or green spaces or neighborhood parks. An estimated 1,986 residents live within a one-half mile walking distance of the existing donation parcels. Of those 1,986 residents, 1,400 residents do not have access to any improved green, open spaces or neighborhood parks within a one-half mile walking distance of their homes. An undetermined number of future residents including families will also be served once the homes are occupied.

TREES AND SHADE

North San Fernando Road Park will be developed as an open space park. The final design of the Park will be completed by RAP's Planning, Construction and Maintenance staff at a later time taking into consideration community input and RAP park standards with design amenities addressing tree and shade amenities.

ENVIRONMENTAL IMPACT STATEMENT

A Phase I Environmental Site Assessment (ESA) was prepared in April 2012 for the parcel proposed to be dedicated for park purposes in accordance with the standards for All Appropriate Inquiries. The Report concluded that there were no recognized environmental conditions or controlled recognized environmental conditions on or near the parcel. An updated Phase I ESA will be prepared to determine if any new environmental conditions have occurred since 2012.

RAP's staff has determined that the subject project has been previously evaluated for potential environmental effects and was determined to be exempt from the California Environmental Quality Act (CEQA). A Notice of Exemption was filed with the Los Angeles County Clerk on June 20, 2013. The current Board action is consistent with the existing CEQA exemption and the project will not result in any additional environmental impacts. No additional CEQA documentation is required pending the results of the updated Phase I ESA.

FISCAL IMPACT STATEMENT

The acceptance of the donation parcels and approval and execution of the final plans for the landscaping project will not have any impact on the RAP's General Fund.

The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Quimby funding and other RAP funding.

Maintenance funds for the new park will be requested as part of the RAP's General Fund. This request will include part time staff, materials and supplies and would provide maintenance seven days a week, year round.

- 1. Approve the scope of the North San Fernando Road Park New Park Development Phase II (PRJ20915) Project, as described in the Summary of the Report;
- Authorize the Department of Recreation and Parks' (RAP) Chief Accounting Employee to establish a new Quimby Fees Account No. 89460K-XX with North San Fernando Road Park as the Account Name;
- Authorize RAP's Chief Accounting Employee to transfer \$320,130.00 in Quimby Fees from the Quimby Account No. 89460K-00 to the North San Fernando Road Park Account No. 89460K-XX;
- 4. Approve the allocation of \$320,130.00 in Quimby Fees from the North San Fernando Road Park Account No. 89460K-XX to the North San Fernando Road Park New Park Development Phase II (PRJ20915) Project; and,
- 5. Authorize RAP's Chief Accounting Employee to make technical corrections as necessary to carry out the intent of this Report.

SUMMARY

North San Fernando Road Park is located near the corner of North San Fernando Road and Astoria Street, in the Sylmar area of the City. This 0.24 acre site was donated to the City by the developer of an adjacent 84 unit residential development project (Report No. 16-232). Approximately 1,986 City residents live within a one-half (1/2) mile walking distance of North San Fernando Road Park. Due to the facilities, features, and services it will provide once

complete, North San Fernando Road Park will meet the standard for a Neighborhood Park, as defined in the City's Public Recreation Plan.

As a part of the donation of the park site to the City, the developer was required to complete Phase I of the development of North San Fernando Road Park (Report No. 16-232). The scope of Phase I included grading, landscaping, utility installation, and fencing. Phase II of the park development is to be designed and constructed by RAP.

PROJECT SCOPE

The design of Phase II of the park development is now complete.

The scope of the North San Fernando Road Park – New Park Development Phase II (PRJ20915) Project includes new play equipment/surfacing, new fitness equipment/surfacing, irrigation, landscaping, security lighting, and park site amenities such as trash cans, benches, and drinking fountains.

RAP staff estimates the North San Fernando Road Park – New Park Development Phase II (PRJ20915) Project will cost approximately \$317,200.00.

PROJECT FUNDING

Upon approval of this report, \$320,130.00 in Quimby Fees will be transferred from the North San Fernando Road Park Account No. 89460K-XX and will be allocated to the North San Fernando Road Park – New Park Development Phase II (PRJ20915) Project.

The total Quimby Fees allocation for the North San Fernando Road Park – New Park Development Phase II (PRJ20915) Project would be \$320,130.00.

These Quimby Fees were collected within two (2) miles of North San Fernando Road Park, which is the standard distance for the allocation of the Quimby Fees for neighborhood recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3.

PROJECT CONSTRUCTION

RAP staff has determined that sufficient funding has been identified for the construction of the North San Fernando Road Park – New Park Development Phase II (PRJ20915) Project.

TREES AND SHADE

Ten (10) 36" box trees (species to be determined), and a free standing shade structure, will be installed as a part of the Project. Additionally, shade will be added with the installation of the new play area, as the new play area includes integrated shade toppers.

ENVIRONMENTAL IMPACT STATEMENT

RAP staff has determined that the subject project has been previously evaluated for potential environmental effects and was determined to be exempt from the California Environmental Quality Act (CEQA). A Notice of Exemption was filed with the Los Angeles County Clerk on June 20, 2013. The work funded by the current Board action will not result in any additional environmental impacts, and therefore, is covered by the existing CEQA exemption. No additional CEQA documentation is required.

FISCAL IMPACT STATEMENT

The approval of this allocation of Quimby Fees will have no fiscal impact on RAP's General Funds.

The estimated costs for the design, development, and construction of the North San Fernando Road Park – New Park Development Phase Two (PRJ20915) Project is anticipated to be funded by Quimby Fees or funding sources other than RAP's General fund. Funding for the maintenance cost of the Project will be requested through RAP's new and expanded facilities budget request process.
