#### RECOMMENDATIONS

- 1. Approve the proposed Brightguard, Inc. (Brightguard) sunscreen program sponsorship recognition signage attached hereto as Attachment 1 to this Report and as described herein, to be displayed on sunscreen dispenser stations installed at approximately fifty-four (54) Department of Recreation and Parks (RAP) pool centers Citywide at the sites set forth in Attachment 2 to this Report, through a sponsorship provided by Brightguard at no cost to RAP in accordance with the RAP Sponsorship Recognition Policy; and,
- Authorize staff to issue a Right-Of-Entry permit for the fifty-four (54) proposed RAP sites
  to Brightguard stipulating the terms and conditions for the installation, sunscreen
  replenishment, and maintenance of the various sunscreen dispensers in coordination
  with and under the oversight of the RAP Aquatics Division.

#### SUMMARY

RAP's Aquatic Division, in collaboration with Brightguard, Inc., proposes to provide sunscreen lotion to park patrons at no cost to RAP or the public over the 2019 summer swim season. While RAP already promotes a healthy body through existing recreational opportunities, this initiative will help preserve that healthy body through free access to sunscreen to help prevent against skin damage from overexposure to the sun. Brightguard has committed to installing sixty-four (64) sun-safety dispenser stations at fifty-four (54) pool center locations in Los Angeles. Bright Guard will manufacture, deliver, install, maintain and replenish the sun-safety stations at the pool locations included on the Aquatics Center list attached hereto as Attachment 2. Brightguard will also be responsible to remove the sun-safety stations upon conclusion of the summer swim season. The sturdy, colorful, high capacity, and covered sunscreen dispensers include an unbreakable mirror, and an infrared sensor and battery powered drip system.

Brightguard was established in California in 2014. Since then, they have expanded services to municipal facilities, parks and beaches, K-12 school districts, and various universities across the United States. They have had a successful partnership throughout New York City which has

existed for the last three (3) years. This year, they will install nearly three hundred (300) dispensers and seven (7) towers throughout the New York City boroughs. Brightguard dispensers are also being used at beaches in Tampa Bay and Orlando, Florida; Santa Monica, and certain areas of Orange County, California.

The primary purpose of this collaboration is to support the overall effort of Brightguard and associated sponsors to combat skin cancer caused by over exposure to the sun through the provision of free to the public SPF 30 sunscreen. In exchange for their contributions to this initiative, RAP will recognize and acknowledge Brightguard and associated sponsors for their contributions through the display of sponsorship recognition signage on the sunscreen dispensers, which may include the sponsor's company name and logo and RAP messaging in accordance with the RAP Sponsor Recognition Policy and compliance with City of Los Angeles sign regulations. The design of the dispenser displaying the proposed sponsorship recognition signage is attached to this Report as Attachment 1 and is hereby submitted to the Board of Recreation and Park Commissioners (Board) for approval. RAP will authorize Brightguard's access to the pools to perform dispenser installations, periodic maintenance and as needed product replenishment, through a temporary, revocable Right-of-Entry Permit (ROE) stipulating the terms and conditions for ingress-egress, staging and storage, and specified periods of operation in coordination with RAP Aquatics staff.

This temporary program initiative will launch with a kick-off event in late May 2019, pending Board approval, and will end upon conclusion of the 2019 Summer swim season. The proposed Signs will be installed and remain in place until the conclusion of the summer season at which point they will be removed by Brightguard, subject to evaluation of the program initiative and discussion with RAP regarding any potential future collaboration between RAP and Brightguard. Should RAP and Brightguard wish to continue this collaboration under the same or modified manner, such action will be documented through a formal agreement or permit amendment to extend the term, subject to the Board's approval, and address any modifications or additional elements to the working collaboration.

### FISCAL IMPACT STATEMENT

The Board's approval of this Report will have no fiscal impact on RAP's General Fund, as all initiative costs will be paid by Brightguard.
