- 1. Approve the scope of work for the John Quimby Park Outdoor Park Improvements (PRJ21322) Project (Project), as described in the Summary of this Report;
- 2. Authorize the Department of Recreation and Parks (RAP) staff to commit from the following fund and work order numbers, a maximum of One Hundred Thousand Dollars (\$100,000.00) in Park Fees, for the proposed Project:

5. Authorize RAP's Chief Accounting Employee or designee to make technical corrections as necessary to carry out the intent of this Report.

<u>SUMMARY</u>

John Quimby Park is located at 7008 Desoto Avenue in the Winnetka community of the City. This 3.82-acre park provides basketball and tennis courts, a volleyball court, and a children's play area, for the surrounding community. Approximately 6,836 City residents live within a one half (½) mile walking distance of John Quimby Park. Due to the facilities and features it provides, John Quimby Park meets the standard for a Neighborhood Park, as defined in the City's Public Recreation Plan.

PROJECT SCOPE

The proposed Project includes the renovation of the existing parking lot, park walkways and pathways, fencing and gates, and the installation of a new hydration station.

PROJECT FUNDING

Upon approval of this Report, One Hundred Thousand Dollars (\$100,000.00) in Park Fees can be committed to the proposed Project.

These Park Fees were collected within two (2) miles of John Quimby Park, which is the standard distance for the allocation of the Park Fees for neighborhood recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3.

The total amount of funding available for the John Quimby Park – Outdoor Park Improvements (PRJ21322) Project is One Hundred Thousand Dollars (\$100,000.00).

PROJECT CONSTRUCTION

Staff has determined that sufficient funding has been identified for the construction of the proposed Project. Construction of the proposed Project is anticipated to begin in October 2019.

ENVIRONMENTAL IMPACT

The proposed Project consists of the renovation of the existing parking lot, park walkways and pathways, fencing and gates, and the installation of a new hydration station at the park. Therefore, RAP Staff recommends that the Board determines that the proposed Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1 (3, 12) and Class 11(3) of the City CEQA Guidelines, and to Article 19, Sections 15301 and 15311 of the California CEQA Guidelines. RAP Staff will file an NOE with the Los Angeles City Clerk and the Los Angeles County Clerk within five (5) working days of the approval of this report.

FISCAL IMPACT

The approval of this commitment of Park Fees will have no fiscal impact on RAP's General Fund.

The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Park Fees or funding sources other than the RAP's General Fund. The maintenance of the proposed park improvements can be performed by current staff with minimal impact to existing maintenance service at this facility.
