**BOARD REPORT** 

- 1. Approve the submission by the Department of Recreation and Parks (RAP) of a continued funding application to the California Department of Education (CDE) for subsidized preschool services at RAP's two licensed child care providers, Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at EXPO Center through the California State Preschool Program (CSPP) for Fiscal Year (FY) 2022-2023 in the amount of Five Hundred Sixty-One Thousand, Eight Hundred Eighty-Four Dollars (\$561,884) for the California State Preschool Program (CSPP) for subsidized preschool services at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at EXPO Center (Application);
- 2. Authorize RAP's General Manager or designee to execute and submit the Application in the form substantially as attached to this Report as Attachment 1, subject to Mayor and City Council approval;
- 3. Adopt the attached Resolution as required for the submission of the Application;
- 4. Direct RAP Staff to transmit a copy of the aforementioned grant application documents to the Mayor, Office of the City Administrative Officer (CAO), Office of the Chief Legislative Analyst (CLA), and to the City Clerk for Committee and City Council approval before accepting and receiving the grant awards, pursuant to Los Angeles Administrative Code

#### SUMMARY

RAP has been receiving funding from CDE for over 35 years to provide child care services at Jim Gilliam Child Care Center, which has a licensed capacity to serve 45 children in a high-need area, and for the last five years at Ralph Parsons Preschool, which has a licensed capacity to serve up to 90 children. CSPP provides funding for subsidized care for pre-kindergarteners. This grant assists with serving children of families with incomes at or below seventy-five percent (75%) of the State median income level.

Studies have shown that preschool programming helps children develop academic, cognitive, and behavioral skills that have proven to increase their chances for future success. The full-day services also give participant's parents, who would otherwise be unable to afford these services, the opportunity to seek employment, or return to school in hopes of creating better economic opportunities for their families.

RAP intends to apply for CSPP funding from CDE for FY 2022-2023 for Five Hundred Sixty-One Thousand, Eight Hundred Eighty-Four Dollars (\$561,884) to be used at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at EXPO Center. The Application requires the Board of Recreation and Park Commissioners (Board) to adopt a resolution attached hereto as Attachment 2. CDE intends to distribute the terms and conditions of the FY 2022-2023 CSPP grant award no later than June 1, 2022, at which time staff will return to the Board for acceptance of the grant award along with its terms and conditions.

#### FISCAL IMPACT

Application of the CSPP grant does not impact RAP's General Fund. If awarded and accepted, the grant would provide funding to continue the subsidized preschool programs at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool within EXPO Center.
