We know that he is looking into fencing off the parking lot. Is that to keep the new residents in or out? What about the Seniors? Seniors need this center for their well being.

Dear RAP Commissioners and Mr. Szabo,

I am forwarding an email I just sent to Tony Royster, GM of the General Services Division of the City. Our Westchester/Playa del Rey community needs information as to whether Mike Bonin has applied for, or whether GSD has issued, a permit for any type of homeless intervention in the parking lot of Westchester Park that serves the senior center, the city library, and the council office. We began with filing PRA requests with GSD several months ago, and we have also made informal requests. We still do not know. In addition, our Neighborhood Council of Westchester-Playa del Rey does not know.

We do know that Mr. Bonin's office obtained estimates to fence that entire lot, and we have provided those to you. We obtained emails by PRA showing that Mr. Bonin's office was making inquiries of another city office about funding for using that lot for Safe Parking (see attachment). Last week, there were surveyors at the parking lot, and also lighting contractors doing a job walk. Within the last month, the RV/van count in the park has doubled.

This is the largest parking lot in Westchester Park, and it makes up about half the parking spaces in the entire park. This is the only parking lot that serves the senior center and the city library branch in the park. If this parking lot is not available, people with disabilities and most senior center users will not be able to use the library or the senior center, and parking in the rest of the park would be insufficient. The CAO determined in his August 10, 2021, report that Westchester Park is not feasible for a Safe Parking program.

We believe the implementation of a Safe Parking (24-hour or just at night) for RVs in that lot is imminent, and we need information as to the plans for that lot.

If there is anything you can do to help us get the information we need, we would appreciate it.

Hey Allison. Hope all is well! I have a few questions for you:

1. This CAO report from 1/24 references, in Attachment 1, the Roadmap tracker for Council Districts. For our district, it says we have a 302 "New Interventions Open and In Process as of December 31, 2021" which are broken down as 131 RRH/Shared Housing, 64 Interim, 77 PHK, and 30 Safe Parking.

Can you share how those 64 interim placements are broken down? (e.g. where they are and what type). Also, Safe Parking LA relayed to me that they have a current max capacity of 50 (25 at each site), how does that factor into the 30 listed?

2. Our office is exploring the possibility of expanding our Safe Parking site at the Westehester Municipal Building (separate from our pursuits with the LAWA site), which is currently Roadmap funded. Could an expansion be supported by Roadmap funding? If so, what would be the process for that?

3. We discussed on a previous call the possibility of getting a more in-depth cost breakdown for Safe Camping and Tiny Homes than what can be found on the Council File for Roadmap. Can you share those breakdowns with me or point me in the right direction for those?

Thanks so much for your help! Please let me know if I should clarify anything.

Subject: Report Back on Evaluation of Site Feasibility and Identification of Funding for Potential Homeless Interventions in Council District 11

### SUMMARY

On May 26, 2021 the City Council adopted recommendations from the Homelessness and Poverty Committee relative to a Motion (Bonin - Ridley-Thomas, C.F. 21-0350) instructing the City Administrative Officer (CAO) to evaluate site feasibility and identify funding for potential homeless interventions at various locations in Council District 11. These sites include: Will Rogers State Beach at 17000 CA-1; Dockweiler State Beach at Lot 3, 11999 Vista Del Mar; Dockweiler State Beach RV Park at 12001 Vista Del Mar; Marina del Rey at Lot 2, 13477 Fiji Way; a Culver City owned site; privately-owned land near 5000 Beethoven Avenue; Westchester Park; Mar Vista Park; Los Angeles World Airports land; and the West Los Angeles Municipal Building at 1645 Corinth Avenue.

The CAO followed its feasibility process as outlined in C.F. 20-1351 to assess the proposed sites. The CAO worked with the Bureau of Engineering (BOE), the Department of General Services (GSD), and the public and private owners of the sites to determine feasibility. Based on these assessments, the majority of the sites are not feasible for homeless interventions, mainly due to infrastructure constraints. The Marina del Rey and the Dockweiler State Beach RV Park sites are still under assessment, and the Los Angeles World Airports (LAWA) is communicating with the Federal Aviation Administration (FAA) about the feasibility of using airport land for homeless interventions. Finally, the City of Culver City has decided to proceed with a homeless intervention on the site it owns in Council District 5, near the border of Council District 11. Discussions regarding partnering on this effort are ongoing.

Council District 11, like Council Districts 1, 5, 7, and 12, lacks City-owned land that can be used for homeless interventions. For these areas, we should continue to identify privately-owned sites that can be leased for homeless interventions and request that the Los Angeles Housing Department pursue properties under the Project Homekey 2 Program. Most of these districts benefited from Round 1 of Project Homekey. In Council District 11, two motels/hotels were purchased, and are now operating as interim housing.

If the sites under assessment are found to be feasible for homeless interventions, the CAO will

include recommendations for the proposed sites' use and funding in upcoming reports.

### RECOMMENDATIONS

That the City Council note and file the report as no further action is required at this time.

### DISCUSSION

The following sites were assessed and found to be infeasible for the reasons outlined below.

### 1. State Owned Beach Sites for Tiny Homes, Safe Parking, or Safe Sleep

Will Rogers State Beach and Dockweiler State Beach are owned by the State of California and managed by the County of Los Angeles. The BOE assessment determined that these sites are cost prohibitive for the following reasons:

- Lack of Infrastructure Capacity: The beach sites were not built for 24/7 residential use, and thus, the sewer infrastructure is not suitable for homeless housing.
- *Lack of Utility Capacity:* The power capacity would have to be increased at both beaches, and the nearest transformer is located 1,000 feet from the sites.
- *Fire Safety:* There are no fire hydrants near these two beaches, and new hydrants would need to be installed as a requirement for residential use.

### 2. Privately Owned Site near 5000 Beethoven Avenue for Safe Sleep

The site is a peninsula of vacant land located southeast of 5000 Beethoven Avenue and is enclosed by the I-90 Freeway, the Ballona Creek, and the Centinela Creek Channel. The BOE assessment determined this site as infeasible for the following reasons:

- No Access to Site: The site has no pedestrian or vehicle access.
- *Lack of Nearby Utilities*: Utilities are situated far from the site, and capacity is uncertain. The closest sewer connection is 500 feet away, the closest water source is 800 feet away, and there is no apparent source for power within 1,000 feet.
- *Expensive to Develop*: The terrain is rough and substantially contoured, which would require considerable grading and soil removal to level the site for access and placement of pallets for administrative purposes, hygiene trailers, and tent spaces.

### 3. City Owned Westchester and Mar Vista Parks for Safe Sleep

The Department of Recreation and Parks (RAP) assessed the proposed sites, and recommended that these parks not be used for the following reasons:

• <u>Sites Are Not Underutilized</u>: Prior to the pandemic, both Westchester and Mar Vista Parks experienced varied and robust recreational usage. Data from both parks show that on average more than 6,000 youth participants attend and utilize the parks and facilities. The parking lots are needed for pick up and drop off for programming and aquatics. Both parks returned to normal operations on June 14, 2021, and

programming is planned through the end of the fiscal year. The RAP sites that are being used for homeless interventions are on underutilized park land.

• *Revenue Generating*: These parks generate more than \$500,000 in annual revenue for RAP.

These two parks should be considered for targeted outreach to connect people experiencing homelessness to housing and services through "Encampment to Home" or similar models.

### 4. City Owned West LA Municipal Building for Temporary Shelter

The evaluated site at the West LA Municipal Building is an approximately 5,500 square foot vacant office space with 24 enclosed offices on the second floor of the building. The State Emergency Shelter Declaration allows the City to use non-residentially zoned properties for shelter according to alternative health and safety standards. These standards limit shelter sleeping quarters to the ground floor. This standard has also been codified in the Los Angeles Municipal Code § 91.8605.2, 2.E. The Municipal Building is zoned as public facilities, and thus, not feasible for shelter use. Even if the zoning was changed to accommodate shelter, the available space is too small to make an interim housing project viable. An interim housing facility should be a minimum of 13,000 square feet to provide up to 70 beds, administrative offices, hygiene facilities, common space, and storage, to make it financially and programmatically viable.

The following sites are still under assessment.

### 1. County Owned Marina del Rey Site for Tiny Homes or Safe Sleep

The proposed Marina del Rey site, located in Lot 2 at 13477 Fiji Way, is an underutilized parking lot owned by the County of Los Angeles adjacent to a boat launch and commercial buildings.

• *Utility Capacity:* BOE's final assessment and Rough Order of Magnitude is pending a report from the County Department of Public Works on sewer, water, and power capacity.

### 2. State Owned Dockweiler Beach RV Park for RV Safe Parking

The proposed site at 12001 Vista Del Mar is still being assessed by BOE.

3. Los Angeles World Airports (LAWA) Owned Site for Tiny Homes, Safe Parking, or Safe Sleep

LAWA has identified possible sites for homeless interventions and requested that the Federal Aviation Administration (FAA) review for approval. The FAA would have to agree to allow the use of airport land for homeless housing and waive the requirement that land purchased with FAA funds be leased at market rate.

### Culver City Owned Site for Tiny Homes or Safe Sleep

The proposed site is a parking lot in the City of Los Angeles but owned by the City of Culver City in Council District 5, near Council District 11. Culver City is not interested in leasing the site to the City. Instead, Culver City plans to develop the site as a homeless intervention and is open to collaborating with Council Districts 5 and 11 regarding the utilization of the intervention. BOE has provided sample layouts for Tiny Home and Safe Sleep Villages.

### **FISCAL IMPACT**

There is no impact to the General Fund at this time.

I am writing to you today in shear frustration over the failed policies that are hurting our youth and our seniors in Westchester and neighboring communities. I will use facts to provide you with compelling reasons why homeless encampments at our park parking lot and the lack of removal is harming the masses.

1. The community is grossly under the city's parkland acres minimum for healthy communities

Darryl Ford, Superintendent of Planning, Maintenance and Construction said in a July correspondence: "The Westchester - Playa Del Rey Community Plan Area, within which the project is located, has a parkland acres-to-population ratio of neighborhood and community parks of 2.4 acres per 1,000 residents. The Public Recreation Plan, a portion of the Service Element of the City's General Plan, sets a goal of a parkland acres-to-population ratio of neighborhood and community parks of 4.0 acres per 1,000 residents." This was based upon old 2020 population data not 2022 which lowers the ratio to 2.0 acres per 1,000 people. Therefore, policies that make this space unusable by the community further impacts the parkland available for the population it is supposed to serve not meeting the city's own standards.

#### 2. Exercise and greenspace has proven benefits for mental health and wellness

Our seniors and children have been forced away from Westchester Park due to the homeless encampments and the continual torment these people inflict on these vulnerable groups. By now you have received reports with the myriad stabbings, fires, sexual assaults, physical assaults and thefts that continue to plague families and seniors trying to use the park by violent homeless people. Last week were two documented assaults that have left the children and their families in fear to go to the park again. The mental wellness of our children are at risk. Exercise is known to help with stress and anxiety and help their wellness. Don't they count? Where can their families park without the fear of being assaulted if these unruly violent homeless take over the sacred few parking spots close to the library and tennis courts? It really is putting the community at a known risk by allowing these homeless people to illegally camp in the parking lot. By allowing homeless to camp in the parking lot, you are complicit in the violence on and mental wellbeing of our youth.

3. Seniors and Physically Challenged need handicapped access to the senior center and the library

Our seniors need the senior center and the library to keep them from becoming homeless. They get food, legal counseling, exercise programs, supportive services to allow them to remain in their home. They use the library as a life saving cooling center during the hot summer months. They also use the library for the resources including the use of their computers, as most don't own their own computer. Physically challenged people who are unable to use the park facilities seek solace in using the library for mental escape and learning. BUT, they can't get to the front door due to the homeless encampment encompassing all of the handicapped parking spaces (see below). Will seniors die from heat stroke this summer because they cannot park close to the entrance in the handicapped spots? Will they park much further and risk being assaulted? Or will they fall and break a hip because the walk is too far? Don't they matter? By allowing homeless to camp in this parking lot, you are complicit in the violence on and wellbeing of our seniors and physically challenged.


4. There are, on average, 370 available Safe Parking spots any given day for campers/cars/vehicles to park in Los Angeles and 20+ excess capacity before LAWA Safe Parking site opens in Westchester

The Los Angeles Homeless Services Authority tracks the available Safe Parking spots by city and by district. Below shows that in our district since 2020, we have not exceeded 50% capacity for Safe Parking. Before the LAWA lot opens for Safe Parking we already had more spots than "enrolled" (in dark blue) and users (in light blue). The data shows that availability of spaces is not the issue. LAHSA has places to move these homeless people to and these resources have been offered to them. The homeless encamped in the parking lot choose not to use the resources offered to them.

The pool is in poor shape and needs serious rehabilitation. People go to other parks, because it is in such poor shape.



Now, in one if it's final acts as manager, LAEC Inc. has informed all tenants that they will raise our boards 8.5%.

We as a group are greatly disappointed that after supporting and rallying for your proposed changes that RAP, Rachel Ramos and Joe Salaices have allowed LAEC Inc. to strong arm us by raising our board in an attempt for LAEC Inc. to obtain a final money grab on their way out the door.

The property still remains in disrepair, with several code violations and no improvements were done nor are we aware of any planned.

During the discussion regarding the new contract for ASM global, Joe Salaices assured us that there would be no board increase for a minimum of two years. With the economy crashing it is unfathomable that representatives of the city of Los Angeles would go against its word and allow this increase, which will further jeopardize members of the already fragile equestrian community, all while lining the pockets of LAEC Inc.

Per Mr Salaices letter, below, it's puzzling that while on a 90 day notice of termination is in effect, LAEC Inc. would be allowed to change the current financial obligations of its boarders. Especially with less than a months notice, all while LAEC Inc. is technically being removed from controlling and managing the City property.

As a group we believe in the promises given and were excited for the possibilities that new management will bring to the facility. Namely in fixing the conditions of the facilities. Unfortunately our excitement has turned to concern as it appears you are wilfully allowing LAEC Inc. to retaliate against us because we supported your position against LAEC Inc. Such a retaliation cannot stand. We expect RAP to enforce the promise of no board increases and to put a stop to LAEC Inc.'s illicit behavior. In particular we want assurances from RAP that they will not condone nor enforce the retalitory increase during the transition period.

Dear Boarders, Trainers and Equestrian Community:

On May 5, 2022, the Recreation and Parks (RAP) Board of Commissioners, in a 5-0 vote, approved Board Report 22-114. The report contains information on the intentions by RAP regarding the future of the Los Angeles Equestrian Center.

Two approved recommendations in the Board Report are to authorize the General Manager of RAP to issue a ninety (90) day notice of termination to the LAEC Inc. and to appoint ASM Global as the interim facility manager of the Los Angeles Equestrian Center.

Soon after the Board Report was approved, LAEC Inc. filed a lawsuit against the City of Los Angeles and RAP, arguing

that RAP does not have the authority to terminate the agreement with LAEC Inc. RAP is defending that lawsuit. RAP will also ensure a qualified operator takes over the Equestrian Center's operations the moment LAEC Inc. leaves the site, regardless of when that occurs. Those plans include the continued operation of all existing boarding facilities and equestrian services.

The Department of Recreation and Parks is fully supportive of the equestrian community and is committed to the future of the Los Angeles Equestrian Center as a public asset that puts the health and safety of the horses and visitors first, that is equitable to the diversity of the region and provides a unique, high-quality recreational experience for the equestrian community.

On Tue, Jul 26, 2022 at 12:39 PM Miriam Preissel > wrote: To all that SHOULD and CAN help the biggest dog park in LA, serving the surrounding areas and being the only dog park for the west SFV, hosting a diverse patronage of race and income, seniors and disabled.

I am pretty upset and attaching photos of what they did to the trees. These trees became distressed because they STOPPED WATERING when people complained about mud. This didn't happen yesterday. This happened over the last few YEARS. So instead of adjusting or figuring out where that was a problem they stopped watering enough to sustain mature trees.

Ultimately our trees became distressed and need deep watering. Basins or berms, mulch and water. Pretty simple.

Arthur Flores, RAP arborist came out to check the trees and to get rid of branches that were in danger of coming down. I asked about what the trees needed and he said deep watering 30-50 gallons twice a week right now through the heat. I asked if they were going to do that and he said he "had no idea".

So I went in last night and realized they brought in bulldozers and diggers and dug up around the trees to make berms. The roots of these trees are on top of the ground because that's where the water comes from, the sprinklers. But they dug around the trees with heavy machinery and on top of not watering, they dug and ripped up roots that spread out around the trees that were just supposed to get water.

I reached out to Arthur and asked if he ordered this and he replied: "No, not at all, I think they need to cut whatever roots are protruding from the ground with a lopper or a hand saw. Then they need to cover with mulch and give water.

I will reach out to Brian Yamasaki to have them correct the issues ASAP."


I think Cesar Lomeli is the most conscientious maintenance person that I've dealt with on daily issues at the park. He has a lot to learn and I don't think he made this decision, at least I hope not. The arborist was there and this should not have happened, so there had to be someone who over rode the department tree surgeon.

This is a mess. I don't have confidence in the people that are overseeing our park and I have no idea how this gets fixed but there has to be enough concern from everyone to seriously address this lack of oversight the last few years. There is an Army Corp Master Plan that has been totally ignored. I believe they should be brought in to deal with the erosion that has worsened with the lack of watering. We have lost at least an inch of dirt and it's like sand on cement. This is beyond what the supervisors at RAP can deal with and someone has to oversee them so they actually take the expert advice when it is given.



TRANSIENT CRIME AT PAN PACIFIC PARK

Hello Commissioners:

I have attached a picture taken last night at about 7:30 pm just adjacent to Pan Pacific Park, of a transient with his pants open, clearly under the influence of drugs or alcohol, exposing himself, who proceeded to walk into the park which was filled with families. When the police finally arrived over two hours later. I was informed that all they did was drive by the park and didn't even enter the park to find the transient. Even though they made no effort to even enter the park and find the suspect, in their report they claimed that "The suspect is no longer in the area." In fact, the transient in question can regularly be found living in the park. Ironically, I was at the park last night to take pictures of the alleged arson fire that took place at the park on July 12, 2022. between midnight and 1:00 am, when the park is supposed to be closed, which destroyed a children's playground which many of us in the neighborhood worked very hard to get built with private donations (see attached pictures). I had been informed earlier in the day vesterday by a captain at LAFD Arson, that his office had never been informed of the fire which took place two weeks ago, so that an investigator could have been assigned to investigate it for possible arson by the many transients that live in the park. Unfortunately, the park management failed to contact LAFD Arson prior to having all the evidence removed by Recreation and Parks maintenance workers. Rather than park management, I had to arrange to get LAFD Arson to finally investigate the fire. However, since all the evidence was already removed at the instruction of park management, it is probably too late for Arson to be able to find those responsible for the fire!

There is a long history of crimes associated with transients in and around Pan Pacific Park. A few years ago, a transient used his own blood to paint swastikas on one of the other children's playgrounds, as well as splattering his blood all over the adjacent bathroom which is frequented by children. Because of this history with transients, and the recent upsurge of transient living in Pan Pacific Park, I had been begging the LAPD Wiishire Division Captain as well as well as the manager of Pan Pacific Park, Eric Calhoun and his superior Elane Piha to increase the police patrols at the park and start again to close the park at 10:00 pm as use to be done. I had also been begging them to finally remove the transient encampments located all over the park as we had been promised many months ago. Unfortunately, my request fell on deft ears and now a children's playground in the park has been burned down! I have been told by the Park Rangers


management that they do not have enough officers to patrol all the parks in Los Angeles and only patrol seven. Pan Pacific Park is not one of them. General Services Police use to patrol Pan Pacific Park on a daily basis. They would walk the park every night at closing to remove any one still present. After their department was phased out and the responsibility was turned over to LAPD, there are no longer daily patrols or closure of the park every night. Based on what occurred last night with the transient exposing himself, it appears that even when a citizen advises LAPD of crime taking place in the park, they can't even be bothered to go into the park and the best we get is a drive by of the adjacent streets!





I wanted to let you know I spoke with Anthony Gallo this morning he assured me that courts #7 and 8 will be painted so that your group will no longer have to tape anything down. This will happened most likely soon as there are two projects left ours being one of them. Those courts are available for play to Pickleballers on Tuesdays, Wednesdays, and Thursdays from 9-12pm.

Monday and Friday starting again in Sept. the large gym will be open for Pickleball from 10-1pm. The fee is \$10 monthly.

Regarding Saturdays and Sundays, I spoke with Anthony and I will obtain a permit application to have courts 7 and 8 from 8am-12pm and open it up to Pickleball. I will be more than happy to cover the cost of this through the center.

Hi everyone,

Thanks again to everyone here at the City of LA Dept of RAP for helping us to get these 2 tennis courts converted into hybrid tennis/pickleball courts. I just wanted to make sure that we are all on the same page. I understand that the pickleball court lines were just painted on 2 of the tennis court at the Van Nuys/Sherman Oaks tennis court and I hope that we are next. Here is the picture of 1 of the tennis court there with yellow lines, which is the perfect color, for Pickleball court.



However, as you can see here there are ONLY 2 pickleball courts on this 1 tennis court, 1 on each side of the net. This will not be enough for our group of players of 150+. Hopefully, City of LA Dept RAP understands that you can fit up to 4 pickleball courts onto 1 tennis court, 2 on each side of the net, like what we've been doing by taping the lines at the Palisades. See an example here at the Granada Hills Rec Center - Petit Park:



Therefore, we hope to see that tennis court #7 will be convert to 4 hybrid Pickleball courts + tennis court #8 will also be converted to 4 hybrid Pickleball courts. This will result in a TOTAL of 8 hybrid courts for Pickleball which will maximize the use of these 2 tennis courts for Pickleball. Trust me when I say **"If you build it,** *they* **will come."**
