RECOMMENDATIONS

1. Approve the proposed changes to the Schedule of Rates and Fees for Golf as set forth in the Attachment A to this Report and as described in the Summary of this report, effective September 1, 2022, upon approval of this Report by the Board of Recreation and Park Commissioners (Board) and subject to the approval of the United States Army Corps of Engineers (USACE) where applicable;
2. Direct Department of Recreation and Parks (RAP) staff to request approval from USACE of the revised golf green fees for those golf courses located on USACE property;
3. Authorize RAP staff to amend the Schedule of Rates and Fees for Golf to incorporate the aforementioned changes; and
4. Authorize RAP staff to make technical corrections as necessary to carry out the intent of this Report.

SUMMARY

The Department of Recreation and Parks (RAP) Golf Division maintains and operates seven (7) 18-hole golf courses, three (3) 9-hole golf courses, two (2) 9-hole pitch and putt golf courses, and a golf training academy. The training academy provides golf instruction to youth under the age of eighteen (18) and performs significant outreach to inner city underprivileged children. City employees perform all maintenance, starter, and electric cart fleet management on each golf facility. The Golf Division also self-operates all five

(5) of its driving ranges and pro shops. All salary expenses, including indirect costs of employees, utilities, supplies and contract services, are funded through revenue generated by the golf facilities. In addition to covering operational expenses, it is essential that the Golf Division generate additional revenue to maintain and improve the City's golf assets.

A comprehensive fee increase is necessary in order to meet significant increases in labor costs, golf maintenance and operational supply expenses, increased utility costs, and for increased capital reinvestment in Golf's infrastructure. The last comprehensive increase of golf fees was approved by the Board on April 5, 2016, effective May 1, 2016 (BR 16-079). The proposed Schedule of Rates and Fees for Golf is attached as Attachment 1 to this Report and is marked to show changes from the previously authorized rates and fees for golf operations.

GREEN FEE INCREASES

This Report proposes an increase of golf green fees (i.e. the price to play golf on a golf course) at all twelve (12) golf facilities, leading to an estimated increase in annual revenue of \$2.0 million. City golf green fees have not been significantly increased since May 2016. During this period, costs of maintaining the courses have increased dramatically. A comparison of the City golf green fees to the Los Angeles County golf green fees reveals that the City golf green fees are significantly under market.

Under authorization granted under Board Report 16-079, which authorized staff to implement certain changes to golf fee pricing using a yield management and dynamic pricing model, some fee changes have been implemented between May 2016 and June 2022 as deemed necessary to increase rounds and revenue. Under that Board Report, the Board also approved a maximum “ceiling price” for green fees which would not be exceeded due to such fee changes. Examples of these fee changes included:

1. Elimination of Friday fees – Monday through Thursday fees became applicable to Friday in order to increase the constantly decreasing Friday rounds. The elimination of the Friday fee has been extremely successful, significantly increasing Friday rounds;
2. Increase in green fees at Los Feliz, Rancho Park 9, Woodley Lakes and Hansen Dam;
3. Implementation of a weekend and holiday morning premium fee at all courses to maximize revenue during peak weekend morning hours.

Under this report, staff is recommending that all temporary dynamic and yield management pricing instituted since Board Report (BR) 16-079 be established as permanent fees. As part of the new proposed fees, there will be new green fee pricing for all of the golf courses for morning (currently from course opening to 9:00 a.m.) weekend tee times. The tables below summarize all posted fees from 2016, current fees revised to reflect pricing authorized under dynamic pricing and yield management authorization, and proposed new posted fees for regular play as well as for seniors. Junior green fees will not change. The existing rates and fees manual include fees for Holmby Park but it is not listed in the proposed fee schedule because Holmby Park is no longer maintained by the Golf Division. It is maintained by RAP’s Maintenance Division.

ELECTRIC CART FEE INCREASES

Under authorization granted for implementation of yield management and dynamic pricing in BR 16-079, in June 2021, electric cart rental fees were increased from \$14 per rider to \$16 per rider (the authorized ceiling price) at the 18-hole courses and from \$14 per cart to \$8 per rider at Harbor Park Golf Course. The increase was to raise fees to going market rates as well as to cover increased costs related to the golf cart lease, maintenance, technology, insurance and labor. RAP staff is proposing making the temporary fee increase permanent. In addition, RAP staff is proposing increasing the per rider fee at Harbor Park Golf Course to \$10 per rider to make it consistent with the 9-hole cart rental fee at the 18-hole courses.

INCREASE IN CEILING PRICE

Under BR 16-079, a ceiling price for green fees, electric cart fees and other golf fees was established in order to provide the Golf Division with the flexibility needed to implement a component of dynamic pricing whereby rates that are above the regular posted rates are available to be charged for periodic/limited purposes. Staff is recommending an increase in these ceiling prices such that staff may continue to implement the yield management and dynamic pricing model, allowing staff to increase or decrease rates and fee in response to increased or reduced demand without any increase exceeding the approved ceiling prices. RAP is proposing the following increases in current ceiling prices:
