### Metro Region - 2022 Tournament Format

### **Covid-19 Guidelines**

- 1. Full-Time staff will be checking all 12 and older Vaccination status to enter at the main entrance. **Indoor Vaccine Ordinance 18721 guidelines are still in effect indoors.** (It is not necessary to check the athletes since it was a prerequisite to join at the local park)
- 2. Social distancing is strongly recommended, there is no limit for participants but overcrowding will be prevented.
- 3. Teams will have a designated area to wait for the next game in order to prevent overcrowding.

### All Star Format

- 1. 2022 Citywide Volleyball rules shall apply.
- 2. All players, coaches and staff must sign the game card / sign in sheet prior to playing in the game.
- 3. We are not allowing teams that are waiting to play to enter the gym. We will have a designated area in case of inclement weather. (room, lobby, etc)?
- 4. Home and visiting team are listed on the schedule and will be positioned on the same side of the court. All parents and spectators will remain on the opposite side of the court and are not allowed on the team benches.
- 5. Coaches must sign a Code of Conduct and are responsible for conduct of their teams and fans.
- 6. Teams forfeiting due to:
  - a. Code of Conduct violation
  - b. Playing an ineligible player during the tournament.
    - i. Will forfeit their last game and their opponent shall advance.
- 7. It is the responsibility of the coach to find out when and where their team plays when advancing in tournament play.
- 8. The winning team in each division will move on and play in Citywide Single Elimination play.
- 9. In the event of a pool play tie the winner will be determined as noted below:
  - a. Head to head record
  - b. Fewest points allowed
- 10. Games will start on time. There is no grace period. It is up to each team to allow proper travel time to get to each game venue on time.
- 11. Minor Divisions will use Volley-Lite Volleyballs. The Majors and Junior Division will use standard High School Volleyballs.

- 12. Teams will play best 2 out 3 sets to win the match. Cap on the first 2 sets is 35 and in the 3rd set it is 25.
- 13. Mandatory Play Rule: A mandatory rotation is required when the serving team fails to win the point or makes an illegal play (side out), 1 bench player must rotate into the game.
- 14. The Sports Board will provide the official game ball.
- 15. Rules Protest Procedures: Protests will only be accepted concerning a misinterpretation of the rules by only the Head Coach (not an Assistant Coach). Coaches must notify officials prior to the start of the next play if there is a protest. The game will be stopped at that point and the committee will be called to make the final decision. The committee's decision shall be final. Protest time is not part of game time. Protests will not be heard on official's judgment calls.
- 16. Eligibility Protest Procedure: The Sports Board has taken reasonable steps to verify that all players in the tournament meet eligibility requirements. All players must appear on a league roster and have shown a valid proof of age. Any eligibility protests require proof from the manager that is protesting. A hearing will be held on such protests and the decision of the committee is final. Eligibility protests must be made immediately after the last game played.
- 17. Any player, coach, or spectator that is ejected from the game, must leave the immediate vicinity of the playing field/court. The Citywide Sports Board reserves the right to determine a possible suspension of the person ejected based on the severity of the act/s leading to ejection.
- 18. After the conclusion of each game each team must make sure all trash is put away.






Failure to comply with the above rules may officially end the game and result in a forfeit loss for the offending team(s).


